

# BOARD OF TRUSTEES BOARD MEETING MINUTES April 19, 2017 – 12:30 p.m.

## 2. Minutes

Board Meeting Minutes of March 15, 2017
 Trustee Frye approved the Board Meeting Minutes of March 15, 2017; second. Vote unanimous; motion carried.

## 3. Public Comments and Presentations

- MCC's Literary Magazine River Voices. Shauna Hayes, Adjunct English Instructor, and Michael Dietz, the student editor of River Voices, discussed and brought this literary magazine back to life. River Voices has been printed on and off since 1970, and was last printed in 2013, before this most current issue. Each Trustee was given a copy of the new publication of River Voices, which will be published annually going forward.
- Kelley Conrad introduced MCC Students Van Vu and Michaela Bosset, nominees to the 2017 All-USA Academic Team, who were named to the 2017 All-Michigan Academic Team and they were congratulated.
- Jeff Johnston, Applied Technologies Faculty, introduced a group of MCC students who competed in the Regional American Foundry Society Competition against four-year universities, taking second place. Brad Cook, President of the Student Chapter of AFS for MCC, Lori Stone, and Tyler Carr talked about their experience at the recent competition. The students redesigned a chair for a company in Shelby, MI and were able to reduce their cost by 46% per part. Using all American made products, they beat the foreign prices, which actually brought production for this company back into the United States. It was also noted that AFS is an international organization, with MCC being the only student chapter from a community college in the entire country.
- Dan Meyers, MCC's Director of Music, announced that an agreement has been signed with the Frauenthal Center in downtown Muskegon. All MCC music ensembles, as well as the West Michigan Concert Winds, the Shoreline Symphony, and the MCC Honor's Orchestra will be performing concerts at the Frauenthal Center beginning in the Fall of 2017.
- Dr. Andy Wible presented his sabbatical request for the Fall 2017 semester to the Board. This request has been approved by the Sabbatical Committee, Department Chair, and Dr. Nesbary. This was presented for information purposes only, no board approval is required.
