June 21, 2023

I. Public Agenda – Chair Osborn called the meeting to order at 12:29 p.m. Trustee Moore moved approval of the agenda. After the Consent Agenda, the Action Items will be moved up. Second. Vote unanimous; motion carried.

II. Public Comments and Presentations

Dr. Patti D’Avignon Dean of Student Services presented the Enrollment Management Plan (EMP) 2023-2024 for year one. The EMP focuses on new students (Recruit), current students (Retain), and past students (Regain).

Sue Samaniego Chief Advancement Officer presented on the Foundation for MCC Revised Bylaws and Documents. President Selmon and Sue Samaniego will serve on the Opportunity Team as non-voting members. College Departments can submit proposals for potential funding opportunities to the Opportunity Team which chooses 3-5 major fundraising priorities. Small projects up to \$10,000 will be awarded by the Opportunity Team. The Opportunity Team will choose larger projects to bring to Cabinet, the MCC Board of Trustees and The Foundation for Muskegon Community College. The Opportunity Team will consist of three faculty members, one member from adjunct faculty, three members from administration, two members from the Educational Support Staff Unit, two members from Facilities, and two at large members. We would like to have students as members of the Opportunity Team in a non-voting role. We will look at retired faculty serving on the Foundation Board. The MCC Board of Trustees will appoint two members to the Foundation and approve the entire Foundation Board of Directors.

Pursuant to the Uniform Budgeting and Accounting Act it is the recommendation of the President that the 2023-2024 Budget, as presented and attached, be adopted, and that the 2023 tax levy for the College's operating millage be established at 2.1693 mills and the 2023 tax levy for the College's capital/debt millage be established at .27 mills on the taxable value and that the Secretary of the Board be authorized to certify the tax levies to township supervisors and city assessors.

In addition to this approval, the Administration will revisit the budget at the October Board meeting and be prepared to make adjustments after our fall enrollment and the State's final budget results have been released. A 5-year multifaceted budget reduction plan and a policy to address a fund balance ratio threshold will be presented at the meeting.

Trustee Crandall moved approval of the budget; Second. Vote unanimous; motion carried.

- B. Trustee Portenga moved approval of the revised Foundation for Muskegon Community College Bylaws, Opportunity Team Policy Statement and Procedures, Opportunity Team Mission Statement, Opportunity Team Proposal Outline and Opportunity Team Proposal Evaluation Rubric documents with the following change to 3.03 of the Foundation for Muskegon Community College Bylaws; Second. Vote unanimous; motion carried.

Bylaws of The Foundation for Muskegon Community College, Article III, Board:

3.03 Election. To become a member of the Board, a person must be nominated by a current director and supported by the Chairperson. If the Chairperson supports the nominee, the Chairperson will present the nomination to the **MCC Board of Trustees, who** will vote on the election of such nominee to the **Foundation for MCC Board of Directors. Additionally, the MCC Board of Trustees will appoint two (2) of their members to the Foundation Board of Directors. These two individuals will not be subject to the term limits referred to in 3.02 above.**

- C. Trustee Crandall moved approval of the Administrative Professional Support Staff (APS SSI Band) Wage Range increase from the current range to the new range of \$14.00 – \$26.73; Second. Vote unanimous; motion carried.
- D. Trustee Crandall moved approval of the Adjunct Faculty Pay Scale to the proposed 2023 scale, and to adjust adjunct faculty pay as appropriate based on the new pay levels; Second. Vote unanimous; motion carried.
